Whereas, it is found necessary to make the society of the region engage in commercial and investment activities and be beneficiary; and to make it play its role in the economic development activities in the region;

Whereas, it is found necessary to extend an operational system which enable the government and private bodies to work in collaboration; and to establish a body that manages such activity;

**Part One**  
**General Provisions**

**1. Mata Duree Gabaabaa**

Dambiin kun “Dambii Waajjira Qindeessaa Walta’iinsa Mootummaa fi Qaamolee Dhuunfaa Mootummaa Naannoo Oromiyaa Hundeessuuf Bahe Lakk 198/2010” jedhamee waamamuu ni danda’a.

**፩. አጭር ርዕስ**

ይህ ደንብ “የኦሮሚያ ክልላዊ መንግሥት የመንግሥትና የግል አካላት ቅንጅት ማስተባበሪያ ጽሕፈት ቤት ለማቋቋም የወጣ ደንብ ቁጥር ፻፺፰/፪ሺ.፲” ተብሎ ሊጠቀስ ይችላል።

**1. Short Title**

This regulation may be cited as “Regulation to establish Oromia Regional State Public and Private Bodies Partnership Coordinating Office No.198/2018.”

**2. Hiika**

Akkaataan jechichaa hiika biraa kan kennisiisuuf yoo ta’e malee, Dambii kana keessatti:

- 1) “Naannoo” jechuun naannoo Oromiyaa ti.
- 2) “Pirezidaantii” jechuun Pirezidaantii Mootummaa Naannoo Oromiyaa ti.
- 3) “Mana Maree Bulchiinsaa” jechuun Mana Maree Bulchiinsaa Mootummaa Naannoo Oromiyaa ti.
- 4) “Mana Maree Waliinii” jechuun mana maree sadarkaa Naannoo, Godinaa, Aanaa fi Bulchiinsa Magaalaa irratti hundaa’u ta’ee hojii walta’iinsa mootummaa fi qaamolee dhuunfaa abbummaan qindeessu, hordofu, deeggaruu fi hojii sosochii ummataa raaw-watu jechuu dha.
- 5) “Dambii” jechuun Dambii Waajjira Qindeessaa Walta’iinsa Mootummaa fi Qaamolee dhuunfaa Mootummaa Naannoo Oromiyaa Hundeessuuf Bahe jechuu dha.
- 6) “Qaama dhuunfaa” jechuun seektara mootummaatiin ala kan ta’e nama dhuunfaa, waldaalee aksiyoona, waldaalee hojii gam-taa fi yuuniyeenota qonnaan bul-totaa, abbootii qabeenyaa biyya keessaa fi alaa, akkasumas kan-neen kaayyoo daldalaatiif hundeeffaman kan biroo ni dabalata.

- ፩) “ክልል” ማለት የኦሮሚያ ክልል ነው።
- ፪) “ፕሬዝዳንት” ማለት የኦሮሚያ ክልላዊ መንግሥት ፕሬዝዳንት ነው።
- ፫) “የአስተዳደር ምክር ቤት” ማለት የኦሮሚያ ክልላዊ መንግሥት አስተዳደር ምክር ቤት ነው።
- ፬) “የጋራ ምክር ቤት” ማለት በክልል፣ በዞን፣ በወረዳና በከተማ አስተዳደር ደረጃ የሚቋቋም ምክር ቤት ሆኖ፣ የመንግሥትና የግል አካላት ቅንጅት ሥራን በበላይነት የሚያቀናጅ፣ የሚከታተል፣ የሚደግፍና የሕዝብ እንቅስቃሴ ሥራ የሚያከናውን ማለት ነው።
- ፭) “ደንብ” ማለት የኦሮሚያ ክልላዊ መንግሥት የመንግሥትና የግል አካላት ቅንጅት ማስተባበሪያ ጽሕፈት ቤት ለማቋቋም የወጣ ደንብ ማለት ነው።
- ፮) “የግል አካል” ማለት ከመንግሥት ሴክተር ውጪ የሆነ ግለሰብ፣ የአክሲዮን ማህበራት፣ የጎብኪ ሥራ ማህበራትና የአርሶ አደሮች ዩኒየኖች፣ የሀገር ውስጥና የውጭ ሀገር ባለሀብቶች እንዲሁም ለንግድ ዓላማ የተመሰረቱ ሌሎችንም ይጨምራል።

**2. Definitions**

Unless the context requires otherwise, in this regulation:

- 1) “Region” Means Oromia Region.
- 2) “President” Means president of Oromia Regional State.
- 3) “Administration Council” Means Oromia Regional State Administration Council.
- 4) “Common Council” Means a council established at the regional, zonal, district and city levels that coordinates follows up and supports the activities of the government and private bodies Partnership; and performs the peoples’ mobilization activities.
- 5) “Regulation” Means regulation to establish Oromia Regional State Partnership of the government and private body coordinating office.
- 6) “Private Body” Means bodies other than government sectors as private person, ax ion associations, cooperatives and farmers’ unions, domestic and foreign investors and includes others that are established with commercial objectives.

7) “Pirojektii” jechuun pirojektii kaayyoo daldalaa qabuu fi akkaataa Dambii kanaatiin wali-igaltee qaama mootummaa fi qaama dhuunfaa jidduutti taa-sifamu irratti hundaa’uun gag-geeffamu jechuu dha.

**3. Daangaa Raawwatiinsaa**  
Seera Daldalaa Biyyaa keessatti kan tumame akkuma eegamet-ti ta’ee, Dambiin kun hojiiwwan daldalaa fi investmentii wal-ta’iinsa mootummaa fi qaamolee dhuunfaa, akksumas qaamolee dhuunfaa jidduutti mootummaa naannichaa keessatti hojjataman kamiyyuu irratti raawwatiinsa ni qabaata.

**4. Ibsa Koorniyaa**  
Dambii kana keessatti jechi koorniyaa dhiiraatiin ibsame dubartiis ni dabalata.

**Kutaa Lama**

**Hundeeffama, Kaayyoo, Gurmaa’insa, Aangoo fi Hojii Waajjirichaa**

**5. Hundeeffama fi Itti Waamama**  
1) Waajjirri Qindeessaa Walta’iinsa Qaamolee Dhuunfaa fi Mootum-maa Naannoo Oromiyaa kanaan booda “Waajjira” jedhamee kan waamamu mana hojii mootum-maa of danda’e ta’ee Dambii ka-naan hundeeffamee jira.  
2) Itti waamamni Waajjirichaa Waajjira Pirezidaantii Mootum-maa Naannichaatiif ta’a.

**6. Kaayyoo Waajjirichaa**  
Waajjirichi kaayyoowwan ar-maan gadii ni qabaata:

1) Sosochii ummataa gaggeessuun hawaasni naannichaa hojiiwwan daldalaa fi investmentii irratti bobba’uun fayyadamaa akka ta’uu fi guddina diinagdee keessatti ga-hee isaa akka bahu taasisuu;

፯) “ፕሮጀክት” ማለት የንግድ ዓላማ ያለውና በዚህ ደንብ መሠረት በመንግሥትና በግል አካል መካከል የሚደረግ ስምምነት ላይ በመመሥረት የሚከናወን ፕሮጀክት ማለት ነው።

**፫. የተፈጻሚነት ወሰን**  
በሀገሪቱ የንግድ ሕግ ውስጥ የተደነገገው እንደተጠበቀ ሆኖ፤ ይህ ደንብ በመንግሥትና በግል አካላት ቅንጅት እንዲሁም በክልሉ መንግሥት ውስጥ በግል አካላት መካከል የሚሠሩ ማንኛውም የንግድና ኢንቨስትመንት ሥራዎች ላይ ተፈጻሚነት ይኖረዋል።

**፬. የጾታ አገላለጽ**  
በዚህ ደንብ ውስጥ በወንድ ጾታ የተገለጸው ሴትንም ይጨምራል።

**፭. መቋቋምና ተጠሪነት**  
፩) የኦሮሚያ ክልላዊ መንግሥት የመንግሥትና የግል አካላት ቅንጅት ማስተባበሪያ ጽሕፈት ቤት ከዚህ በኋላ “ጽሕፈት ቤት” ተብሎ የሚጠራ ራሱን የቻለ የመንግሥት መስሪያ ቤት ሆኖ በዚህ ደንብ ተቋቋሟል፤

፪) የጽሕፈት ቤቱ ተጠሪነት ለክልሉ መንግሥት ፕሬዝዳንት ጽሕፈት ቤት ይሆናል።

**፮. የጽሕፈት ቤቱ ዓላማ**  
ጽሕፈት ቤቱ የሚከተሉት ዓላማዎች ይኖረዋል፡-

፩) ህዝባዊ እንቅስቃሴ በማካሄድ የክልሉ ህብረተሰብ የንግድና ኢንቨስትመንት ሥራዎች ላይ በመሰማራት ተጠቃሚ እንዲሆንና በኢኮኖሚ ዕድገት ውስጥ ድርሻውን እንዲወጣ ማድረግ፤

7) “Project” Means a project hav-ing commercial objectives operating on the basis of con-tracts between the government and private body made in ac-cordance with this regulation.

**3. Scope of Application**  
Without prejudice to the com-mercial laws enacted within the country, this regulation shall be applicable to any commer-cial and investment activity, Partnership of government and private bodies as well as among the private bodies performed in the regional state.

**4. Gender Reference**  
In this regulation, any term ex-pressed in masculine gender shall include the feminine.

**Part Two  
Establishment, Objective, Organi-zation and Power and Duties of the Office**

**5. Establishment and Account-ability**  
1) Oromia Regional State private and government bodies Part-nership Coordinating office, hereinafter called “Office” is hereby established as an auton-omous government institution by this regulation.  
2) Accountability of the office shall be to the president office of the regional state.

**6. Objectives of the office**  
The office shall have the follow-ing objectives:  
1) To make the society of the re-gion engage in the commercial and investment activities and benefit from same and enable it play its role in the ongoing eco-nomic development through conducting people mobiliza-tion activities;

- 2) Hojiin walta'iinsa mootummaa fi qaamolee dhuunfaa bu'uura seeraa akka qabaatuu fi imaammattootni, tarsiimoowwanii fi seerotni sosochii ummatni diingadee keessatti taasisu jajjabeessan akka jiraatan taasisuu;
- 3) Hojiiwwan daldalaa fi investmentii sosochii ummataatiin gaggeeffamu milkeessuuf qaamoleen mootummaa deeggarsa barbaachisaa akka taasisan qaamolee adda addaa waliin qindoominaan hojjachuu;
- 4) Hojiiwwan daldalaa fi investmentii mootummaa fi qaamolee dhuunfaa waliin hojjachuun barbaachisaa ta'an adda baasuun hojiiarra oolchuu.

**7. Teessoo Waajjira Ol'aanaa**  
Teessoon Waajjira Ol'aanaa Waajjirichaa Magaalaa Finfinnee ta'ee, akkaataa barbaachisummaa isaatti damee qabaachuu ni danda'a.

- 8. Aangoo fi Hojii Waajjirichaa**
- 1) Walta'iinsa qaamolee dhuunfaa fi mootummaa ilaalchisee yaa-da imaammataa fi tarsiimoo ni maddisiisa; mootummaa ni gorsa; hojiiarra oolmaa isaanitii fi hojjata.
  - 2) Qorannoo fi qu'annoo irratti hundaa'uun pirojektotni waldaalee aksiyoona akka bocamanii hojitti galan ni hojjata; ni deeggara; ni qindeessa.
  - 3) Hojiiwwan daldalaa fi investmentii walta'iinsa Mootummaa, Qaamolee Dhuunfaa fi Ummataa hundeeffamanii hojii oomishaa, raabsaa, ijaarsaa fi kenna tajaajilaa fi kan kana fakkaatan irratti bobba'an bal'inaan akka hundeeffamanii fi kanneen hojiiarra jiranis bu'a qabeessa akka ta'an hojii qo'annoo fi qorannoo akka gaggeeffamu ni taasisa; haala ni mijeessa; ni qindeessa.

**፭. የዋና ጽሕፈት ቤት አድራሻ**  
የዋና ጽሕፈት ቤቱ አድራሻ ፊንፊኔ ከተማ ሆኖ፣ እንዳስፈላጊነቱ ቅርንጫፍ ሊኖረው ይችላል።

- ፮. የጽሕፈት ቤቱ ሥልጣንና ተግባር**
- ፩) የመንግሥትና የግል አካላት ቅንጅትን በተመለከተ የፖሊሲና ስትራቴጂ ሐሳብ ያመነጫል፤ መንግሥትን ያማክራል፤ ሥራ ላይ እንዲውሉ ይሠራል፤
  - ፪) ጥናትና ምርምር ላይ በመመሥረት የአክሲዮን ማህበራት ፕሮጀክቶች ተቀርጸው ወደ ሥራ እንዲገቡ ይሠራል፤ ይደግፋል፤ ያቀናጃል፤
  - ፫) በመንግሥት፣ በግል አካላትና በህዝብ ቅንጅት ተቋቁመው የማምረት፣ የማከፋፈል፣ የግንባታና አገልግሎት አሰጣጥ እና የመሳሰሉት ሥራ ላይ የተሰማሩ የንግድና ኢንቨስትመንት ሥራዎች በስፋት እንዲቋቋሙና ሥራ ላይ ያሉትም ውጤታማ እንዲሆኑ የጥናትና ምርምር ሥራ እንዲካሄድ ያደርጋል፤ ሁኔታን ያመቻቻል፤ ያቀናጃል፤

- 2) Work for the Partnership of the government and private body to have legal basis ;and for the existence of policies, strategies and laws motivating the activities of the people made in the economic arena;
- 3) Work in collaboration with various government organs so as to enable them make the necessary support for the success of the commercial and investment activities conducted by the peoples mobilization;
- 4) Identify and implement the commercial and investment activities found necessary to be performed with the government and private bodies.

**7. Address of the Head Office**  
Address of the head office shall be Finfine city; and may have branch offices as deemed necessary.

- 8. Power and Duties of the Office**
- 1) Initiate policy and strategy ideas regarding the partnership of the government and private bodies; advise the government; work for their implementation;
  - 2) Based on research and study, work for the projects of ax ion associations to be designed and enter in to operation, support; coordinate same;
  - 3) Cause studies and research activities to be undertaken for the commercial and investment activities established by the Partnership of the government, private bodies and the people and engaged in activities of production, distribution, construction and service delivery and the likes to be established widely and to make those on duty be productive; facilitate condition; coordinate same;

- 4) Kutaaleen hawaasaa adda addaa sosochii diinagdee taasifamu keessatti humna qabaniin akka hirmaatanii fi fayyadamaa ta'an hojii hubannoo uumuu fi dada-maqsuu ni hojjata.
- 5) Abbootii qabeenyaa biyya keessaa fi biyya alaa hojiiwwan daldalaa fi investmentii sosochii ummataa gaggeeffaman keessatti gama faayinaansii, beekumsaa fi teknolojiin hirmaatan ni barbaada; ni hirmaachisa; deeggarsa barbaachisaa ni taasisa.
- 6) Qophii fi hojiirra oolmaa hojiiwwan daldalaa fi investmentii sosochii ummataatiin gaggeeffaman irratti tajaajila gorsaa fi deeggarsa teekinikaa, leenjii dandeettii raawwachiisummaa cimsu ni kenna; akka kennamu ni taasisa.
- 7) Hojiiwwan daldalaa fi investmentii walta'iinsa mootummaa fi qaamolee dhuunfaan hojjatamuu danda'an irratti sosochii ummataa kan hoogganu manni maree waliinii sadarkaa Naannoo, Godinaa, Aanaa fi Bulchiinsa Magaalotaatti akka hundeeffamu haala ni mijeessa.
- 8) Pirojektiiwwan daldalaa fi investmentii mootummaa fi qaamni dhuunfaa waliin irratti hojjachuu danda'an ni xinxala; akka xinxalamu taasisuun mana maree waliinitiif ni dhiyeessa; yammuu hayyamamu hojiirra akka oolu ni taasisa.
- 9) Raawwii hojiiwwan daldalaa fi investmentii mootummaa fi qaama dhuunfaan raawwataman ilaalchisee hordoffii fi deeggarsa barbaachisaa ni taasisa; deeggarsa ogummaa fi teekinikaa akka taasifamu haala ni mijeessa;

- ፰) የመንግሥትና የግል አካላት በጋራ ሊሠሩበት የሚችሉ የንግድና ኢንቨስትመንት ፕሮጀክቶች ያጠናል፤ እንዲጠና በማድረግ ለጋራ ምክር ቤት ያቀርባል፤ ሲፈቀድም ሥራ ላይ እንዲውል ያደርጋል፤
- ፱) በመንግሥትና በግል አካላት የሚከናወኑ የንግድና ኢንቨስትመንት ሥራዎች አፈጻጸም በተመለከተ አስፈላጊውን ክትትልና ድጋፍ ያደርጋል፤ ሙያዊና ቴክኒካዊ ድጋፍ እንዲደረግ ሁኔታዎችን ያመቻቻል፤

- 4) Perform awareness creation and mobilization activities for various segments of the society to participate in and benefit from the ongoing economic strive;
- 5) Seek for the domestic and foreign investors that participate in the commercial and investment activities undertaken by the people mobilization with respects of finance, knowledge and technology; cause them to participate; provide necessary support;
- 6) Provide consultancy service and technical support for the preparation and implementation of the commercial and investment activities undertaken by the mobilization of the people; provide; cause the provision of performance ability building trainings;
- 7) Facilitate condition for the establishment of common council at the regional, zonal, district and city administration levels that manages the peoples mobilization on the commercial and investment activities performed by the Partnership of the government and private body;
- 8) Analyze the commercial and investment projects on which the government and private body can work together; cause it to be analyzed and submit to the common council; cause same to be implemented up on approval;
- 9) Make the necessary follow up and support regarding the performances of commercial and investment activities undertaken by the government and private body; facilitate condition for the provision of professional and technical supports;

- 5) Evaluate the commercial and investment projects up on which the government and private bodies can work together which is identified and submitted to it; put implementation direction;

**19. General Principles**

- 1) Any commercial and investment activity undertaken by the Partnership of the government and private body shall depend on the benefits and profits that such activity generates;

4) Any commercial and investment activity undertaken by the Partnership of the government and private body shall be conducted in a way that ensures transparency, accountability and honesty.

**20. Ways of Presentation of Development Projects or Plans**

The proposal of Partnership project may be submitted by the government or private body.

**21. Commercial and Investment Branches on which Working in Partnership is Possible**

The commercial and investment activities up on which the public and private bodies can work in Partnership shall be the following:

- 1) Activities of agricultural branch;
- 2) Construction activities like construction of buildings, real estates and the likes;
- 3) Industries and manufacturing;
- 4) Mineral and energy development activities;
- 5) Social services delivery activities like education, health institutions;

  - 1) Book of Accounts of the office shall be kept differently in the Books of Accounts of president office of the regional state;
  - 2) Books of Accounts and financial documents of the office shall be investigated time to time by the Auditor General Office or by the body it represents.
- 24. Administration and Financial Services of the Office**  
The office shall be provided with administration services and various finances from office of the president of the regional state.
- 25. Duty to Support**  
Any person has a duty to provide the support expected from him for the implementation of this regulation.

- 2) Without prejudice to the provision under sub article 1 of this regulation, regarding the issues covered in this regulation, activities performed until the date of approval of this regulation shall be considered as performed in accordance with the provisions of this regulation and their performances shall have effect.

**27. Power to Issue Directive**

The common council may issue directive to implement this regulation.

**28. Effective Date**

This regulation shall come in to force as of 18th April, 2018.
